SAWGRASS PLANTATION OF KILLEARN HOMEOWNERS ASSOCIATION, INC. FIRST AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS

THIS FIRST AMENDMENT TO DECLARATION OF RESTRICTIVE COVENANTS (SAWGRASS PLANTATION OF KILLEARN HOMEOWNERS ASSOCIATION) is made and executed this 23 ed day of November 2010, by Sawgrass Plantation of Killearn Homeowners Association, Inc., following the consent and ratification of the amendment by the required number of members of the Association.

WITNESSETH:

Those paragraphs of the DECLARATION OF RESTRICTIVE COVENANTS (SAWGRASS PLANTATION OF KILLEARN) recorded in OR Book 1818, Page 1533, of the public records of Leon County, Florida referenced below are hereby amended to read as follows:

16. EASEMENTS

- E. Parking shall be on the concrete area in front of the unit and the area on each unit's lot shall be for the exclusive use of the unit owner or their tenant.
- 17. <u>TERMINATION</u>. These Restrictive Covenants, but not the easement granted hereby, shall terminate only upon the written consent of the owners of two-thirds (2/3) of all units.

All owners and prospective purchasers of Sawgrass Plantation of Killearn subdivision in Leon County, Florida, please take notice of this reported change in the Restrictive Covenants.

Except as amended herein, all other Covenants and Restrictions remain in full force and effect.


